

Working group mandate:

Swiss Federated Metabolomics/Proteomics Network: concept for governance, processes and infrastructures

Proposed mandate:

The Working Group shall develop a “**Swiss Federated Metabolomics/Proteomics Network**”. The concept should be based on a federated system and should be compatible with SPHN’s environment, principles, and efforts in GA4GH.

Deliverables:

A detailed concept should be provided including:

- Mapping of current Metabolomics/Proteomics landscape in Switzerland;
- Simple use case descriptions for researcher (access to platforms, quality control, bioinformatics services, return of results etc.);
- An overall concept of a federated Metabolomics/Proteomics network enabling sharing and processing genomic data for research ;
- Definition of the interface with the clinical environment (technical and processes);
- Description on the proposed strategy to achieve national harmonisation (considering international standards);
- A concept for biospecimens and data storage and transfer processes;
- Data and sample security with a specific focus on Metabolomics/Proteomics data;
- Definition of roles and responsibility (DCC/BioMedIT network, Metabolomics/Proteomics centers, hospitals);
- Definition of processes for returnable actions in the clinical world and patient healthcare.

To achieve these goals a startup proposal with:

- A work plan (scope and focus, feasibility, timeline, work packages, milestones);
- Resource requirements;
- A list of experts that should be consulted from the Swiss and international community.

Timeline: 6 months.

Proposed work plan:

A series of 3-4 meetings is arranged with the Working Group with 3 weeks between each meeting. During the meetings, the draft concept is discussed and further developed. The meeting documentation should be sent at least 1 week prior to the meeting.

Financial needs for the working group:
