

# SPHN Data Governance Working Group Updated Mandate

January 2025

The Data Governance Working Group (DGWG) was constituted in February 2023 as part of the SPHN initiative with the aim of developing a nationally harmonized contractual framework for the further use of health data in multi-centric projects and to align on a joint data sharing and data governance strategy in such projects. Since the constitution of the working group, the contractual framework has been revised and a nationally harmonized legal agreement template regulating data sharing and use in multi-centric projects has been published. Moreover, controversial topics of national interest, such as “open research data” and effective data sharing models with third parties facilitating “data as product”, have been put on the agenda.

## Vision and Mission

For the current period of SPHN (2025-2028), the group's efforts will continue with a focus on governance aspects for effective data sharing with third parties. **The group's mission is to promote harmonized governance frameworks for data access, enabling equitable and trustworthy further use of routine health data throughout its entire lifecycle.** The goal of a harmonized health data governance is to drive collaboration across the Swiss research landscape to create lasting value for both science and society.

## Work packages

### **Work package 1: Documentation of data access governance at university hospitals.**

WP1 aims to share among stakeholders know-how about data governance practices in university hospitals and universities/ETH/EPF, and to prepare the ground to further align governance practices and promote a common vision for the role and responsibilities of data governance bodies in the Swiss data ecosystem.

### **Work package 2: Establishing common policies for data access governance**

Work Package 2 aims to develop common policies for data governance bodies within DGWG institutions to facilitate data access in underregulated areas, that often lead to fragmented decision-making and delays in granting data access. These areas include the sharing of anonymized data, complex quality projects, exploratory or AI projects.

### **Work package 3: Develop effective data governance models for equitable access and multiple-use of health data**

WP3 aims to advance data governance models for complex multiple-reuse scenarios (e.g. governance of health data made available in scientific repositories) and scenarios without involving a local Principle Investigator.
